- _____ 1. I understand that I release all responsibility from I'm Ready Foundation and its employees, staff, board members and affiliates for damages sustained while participating in any activity conducted both on and off the premises.
- _____ 2. I understand the potential dangers, hazards, and/or risks, directly and/or indirectly inherent in participating in this activity.
- _____ 3. I understand the inherent dangers involved in interstate travel and utilizing transportation and other roadways. I accept transportation and provide services through transportation with the full knowledge and understanding of these risks.

I understand that I, my parents, heirs, administrators or executors release, waive and discharge any action which may hereafter arise; and agree that we (parents, heirs, administrators or executors) will not make any claim for personal injury or property damage against I'm Ready Foundation or against employees, staff or administrators or the same or any agents hired or volunteer acting on behalf of or for I'm Ready Foundation.

I voluntarily assume full responsibility for any risk of loss, property damage or personal injury, including death that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such an activity, whether caused by negligence of releases or otherwise.
